ALL FIREARMS APPLICATIONS ARE BY APPOINTMENT ONLY

FOR ALL RENEWAL APPLICATIONS:

- 1. The completed application form. Must answer all questions and be completed truthfully.
- 2. Positive identification.
- 3. A non-refundable MONEY ORDER or CERTIFIED BANK CHECK in the amount of \$100.00 made payable to "The Town of Ludlow". There is no Charge for persons over 70 for a LTC/FID renewal.

FOR NEW LTC APPLICANTS:

- 1. The completed application form. Must answer all questions and be completed truthfully.
- 2. Positive identification.
- 3. A copy of the Certification Form from a completed **Firearms Safety Course** certified by the Massachusetts State Police which specified it is valid for License to Carry.
- 4. The Firearms Safety Course must also have a 'live-fire' component demonstrating safe-handling of firearms. This must be indicated on the course certificate or an accompanying certificate of live-fire.
- 5. Two (2) Letters of Recommendation are necessary when applying for a new LTC Class A; these letters must be from two persons (not relatives) you have known, for five years or longer, who can testify to your suitability to possess a firearm.
- 6. A non-refundable MONEY ORDER or CERTIFIED BANK CHECK in the amount of \$100.00 made payable to "The Town of Ludlow" This includes first time applicants over the age of 70.

FOR NEW FID APPLICANTS (Class C)

- 1. The completed application form. Must answer all questions and be completed truthfully.
- 2. Positive identification
- 3. A copy of the Certification Form from a completed **Firearms Safety Course** certified by the Massachusetts State Police which specified it is valid for FID Class C, **or a Basic Hunter Safety Education Certificate** issued by the Commonwealth of Massachusetts Division of Fisheries & Wildlife.
- 4. A non-refundable MONEY ORDER or CERTIFIED BANK CHECK in the amount of \$100.00 made payable to "The Town of Ludlow" This includes first time applicants over the age of 70.

FOR NEW APPLICANTS (FID Class D - Mace and Pepper Spray Only) under the age of 18*:

- 1. The completed application.
- 2. Positive identification.
- A non-refundable MONEY ORDER or CERTIFIED BANK CHECK in the amount of \$25 made payable to "The Town of Ludlow. At this time there is no charge for renewing a FID Class D license.
 *NO FID Class D license is required for those over the age of 18.

All applicants will be subjected to a search of their criminal records through the Massachusetts Board of Probation, the State Police, and the FBI. Fingerprints and photographs will be taken by the Department.

Under the Gun Control Act of 1998, and the Mass. General Laws, certain offenses (including certain misdemeanors) that did not disqualify applicants in the past, or in other states, may be a reason for disqualification.

LTC/FID ATTACHMENT

Please carefully review **QUESTION 4** on your application:

"Have you ever appeared in any court as a defendant for any criminal offense (excluding non-criminal traffic offenses)?"

- You do not have to put down non-criminal traffic offenses (e.g. a speeding ticket), but you MUST include any and all criminal offenses. The key word in this question is "APPEARED" (not arrested). It you have ever APPEARED in ANY COURT as a Defendant in a criminal matter you must answer "Yes".
- Having appeared, arrested and/or even convicted of certain misdemeanor crimes may not
 prohibit you from obtaining a firearms permit. However, NOT ANSWERING
 TRUTHFULLY WILL RESULT IN A DENIAL OF YOUR APPLICATION.
- Understand that "appeared" in Court, includes ALL ADULT AND JUVENILE Court Appearances in ANY COURT. It does not matter what the final disposition was (Dismissed, Continued Without a Finding, etc.), you must truthfully answer "yes" and explain the circumstances on your application as required in the space provided. (NOTE: You must provide explanation for any "yes" answers to questions 4-15).
- If you have a SEALED record, please just let us know that the record is sealed. You don't have to explain further the circumstances. However, all sealed records are reviewed for conviction disqualifiers for firearms licensing.
- We cannot accept "I forgot"; or "I was told that I didn't have to show-up"; or "that was long ago", etc. If you cannot remember, request your own CORI check through the Mass. Department of Criminal Justice Services website or call DCJIS at 617-660-4600 to get the form by mail to assist you in providing a truthful answer.

I have reviewed the above-mentioned information and I understand that my application will be denied and I may be prosecuted for perjury if answering untruthfully.
