### Provisions Regarding Door-to-Door Salespersons


M.G.L. Chapter 101 Section 34, sets forth regulations regarding door-to-door sales. Each sales agent/supervisor must register with the Chief of Police and an applicant will be denied registration if the Chief of Police determines "by investigation or receives reliable information" that the applicant has been:

- 1.) convicted of a felony, or
- 2.) is a fugitive from justice, or
- 3.) if the applicant refuses to provide the required information to the Police Chief.

Before a sales agent or group may commence selling goods door-to-door, written notice must be given by the Chief of Police; the Chief may also revoke a registration for "good cause", including the determination that the registrant:

- 1.) has been convicted of a felony, or
- 2.) is a fugitive from justice, or
- 3.) has been charged with a felony while engaged as a sales supervisor.
